

# HSW Festa Italiana Moped Giveaway Terms and Conditions

### Conditions of Entry

- 1. Entry is open to Australian residents over the age of 18.
- 2. Employees of the Promoter and their immediate families are not permitted to enter.

#### How to Enter

- 3. To qualify for the draw, eligible persons must scan one of the competition QR codes displayed on Main Lawn at Howard Smith Wharves, and then complete the linked online registration form.
- 4. Eligible persons may not enter the competition more than once.

#### Duration of the Competition

5. The competition will commence at 3pm on Thursday 29 May 2025 and will conclude at 10pm on Sunday 8 June 2025.

### Details of Prizes

6. There will be two prizes, each consisting of a Rollin Cruise model moped, including colour rear-view mirror set, storage lock box, luggage rack and battery charger.

The total value of the prizes is approximately AUD\$8,600.

### Date, Time and Place of Draw

- There will be two prize draws. The first draw will take place on Monday 2 June 2025 at 3pm. The second draw will take place on Monday 9 June at 3pm.

### Notification of Winner

- 11. Each winner will be notified by email and text message on the day of each draw.
- 12. The winner consents to the use of their name and suburb of residence for promotional and marketing purposes and agrees to participate in reasonable promotional activities as requested by the Promoter.

## No Liability

- 13. To the extent permitted by law, the Promoter is not responsible or liable for:
  - i. inaccurate / incorrect transcription of entry information;
  - ii. purported entries that are not received for any reason, including because they are lost, misdirected or stolen, or that are received, but are late, illegible, incomplete, sent with insufficient postage (where entry is by post), or sent other than as directed in the entry instructions;
  - iii. any problems or technical failures of any kind, including malfunction of any telephone network or lines, computer online systems or network, servers or providers, computer equipment, or software;
    - iv. the unavailability or inaccessibility of any service whether or not caused by traffic congestion on the Internet or at any Website;
      - v. unauthorised human intervention in any part of the competition;
